Lawful Basis

On occasions we may be required to process your personal data for other reasons however we will only do so where a Lawful Basis applies.

Categories of Personal Data

Personal data and special category data provided by the College to the processors may include:

- Name
- Date of birth
- Gender
- Course details
- Unique identifiers
- Language preference
- Contact details (Address/Contact number/Email)
- Ethnicity
- Gender
- Religion (if applicable)
- Educational Background i.e. qualifications
- Disabilities, learning difficulties, long term medical conditions

The College will never ask for information which is not relevant to your survey answer. Processors may also collect meta-data such as screen resolution, method of participation and time taken to complete the survey.

Who will have access to my information, or who will you share it with?

Information may be passed between various sections of the College for operational reasons and may also be disclosed to external agencies to which we have obligations for example Government Agencies and associated Statutory Bodies (e.g. Department for the Economy), College partner organisations, Higher Education Statistics Agency, Government Survey & Research Organisations. We may also disclose information to legal representatives.
